Please share the following with the AAFA Board and Membership as it recounts items of interest that arose during the month of September of 2018 and looks forward to certain events occurring in upcoming months.

**Follow-up on August's upcoming events:**

1. September 3 – 7 – Northern Committee of the WCPFC meeting. A 44-page report of the meeting is available through the attached link - <https://www.wcpfc.int/meeting-folders/northern-committee>. In terms of items related to North Pacific albacore (NPA) – the following were discussed:
  - A. A review of the 2017 stock assessment
  - B. The ongoing Management Strategy Evaluation. A 4<sup>th</sup> MSE workshop is scheduled for March 5-7, 2019 (Yokohama, Japan). It will be imperative that AAFA has presence at this workshop.
  - C. A north Pacific tuna tagging program (led by ISC) - initial focus on NP albacore & Pacific bluefin tuna.
  - D. Data reported from Northern Committee harvesting nations that target NPA:
    - Canada:**
      - Catch in 2017 - 33% less than 2015. ISC asked to investigate this during the next assessment
      - Effort – declined; but less so than the catch decline
    - China** (which was absent):
      - No catch info
      - Effort – China continually reports 10 vessels fishing NPA; but evidence of shift of effort from South Pacific to North Pacific. It was noted this would be in contravention of the NPA effort limitation.
    - Japan** (3 fleets targeting NPA):
      - Catch in 2017 – around 45,000 tons
      - Effort – Similar number of vessel days as in 2016 and below its limit
    - Korea** (No fisheries targeting NPA):
      - Note – there was substantial catch and effort contained in Korea's report to the NC; but Korea claims this is all bycatch
    - Chinese Taipei:**
      - Catch in 2017 – 4,300 tons
      - Effort – 25 longline vessels
    - USA:**
      - Catch in 2017 – unstated
      - Effort – roughly 12,000 days which is well below its limit

- E. Objectives for 2019 – 21
- 1) Follow-up on member’s implementation of effort limitations
  - 2) Implement interim harvest strategy – which includes:
    - a. If limit reference point is breached (ie – if stock falls below a certain threshold)
    - b. Continue work on MSE towards developing a target reference point (ideal amount of take or effort) and other elements of a harvest strategy
    - c. Consider changes in effort limitations
2. September 5 – 12 – Pacific Fishery Management Council Meeting. Among the highlights, as it relates to albacore: (1) A review of the recently completed IATTC meeting, including items mentioned in our August report; and (2) a request for the Council to fund travel for two HMSAS reps to the MSE workshop in Japan in March (this was not addressed by the Council).
  3. September 4 – 17 – UN Intergovernmental Conference session in ABNJ/BBNJ. Additional information on this is available at <https://www.un.org/bbnj/>. While we had planned on watching a good portion of this, due to a family emergency, we were unable to do so. There are 57 hours of webcasts available and a full report will be prepared based on these and other materials submitted for the Conference
  4. September 17 – Bureau of Ocean Energy Management held a meeting of the California Intergovernmental Renewable Energy Task Force. For a list of presentations and maps of viable areas – see <https://www.boem.gov/California/>.

The fine was issued under MARPOL (International Convention for the Prevention of Pollution from Ships). 10. September 25 – A US District Court in Louisiana found that “harvesting” as used in the Magnuson-Stevens Fishery Conservation and Management Act does not include aquaculture. Thus, the Aquaculture Fishery Management Plan adopted by the Gulf Council – and accompanying regulations adopted pursuant to the Magnuson-Stevens Act – were not valid. This could have a profound impact on aquaculture activities planned for federal waters of the US. Note – there is legislation pending in the Senate and House that would directly address this. ## Upcoming items of interest

1. NOAA Listening Sessions: As noted in last month's overview, NOAA is hosting a number of meetings during the fall to "provide information about the implementation of the Department of Commerce's 2018-2022 Strategic Plan, and also offer you the opportunity to give your input. Topics will include the Weather Research and Forecasting Innovation Act of 2017, reducing the seafood trade deficit, and supporting maritime commerce, fisheries, recreation, and tourism." West Coast meeting dates are as follows:
  - Thursday, October 4 – Seattle, Wa. Agenda: To discuss the implementation of The Weather Act, including the development of a community-based weather model.
  - Friday, November 9 – San Diego, Ca. Agenda: To discuss opportunities to improve the efficiency of U.S. ports, promote domestic aquaculture production, and expand exploration of the nation's Exclusive Economic Zone.
2. October 11 – 12 – Permanent Advisory Committee to the WCPFC meeting to be held in Honolulu, Hi.
3. November 1 – 8 – Pacific Fishery Management Council meeting in San Diego, Ca.
